# **Commercial Customs Operations Advisory Committee**

The Commercial Customs Operations Advisory Committee of U.S. Customs and Border Protection (COAC) advises the Secretary of the Treasury and Secretary of Homeland Security on the commercial operations of CBP and related DHS and Treasury functions, including regulations and policies or practices of CBP. The Committee provides recommendations on improvements to the commercial operations of CBP.

COAC consists of 20 members, two government co-chairs, and two government deputy co-chairs. CBP ensures that there is a fair and equitable distribution of industry representation on the COAC.



# **Small Business Regulatory Enforcement Fairness Act**

OTR manages all Small Business Regulatory Enforcement Fairness Act (SBREFA) cases from the Small Business Administration on behalf of CBP.

The Executive Director of OTR is the designated regulatory fairness representative for the agency, with responsibility for promoting compliance with SBREFA.

In coordination with the relevant offices within CBP, OTR responds to concerns from small business to ensure enforcement actions are not overwhelming.

# **Trade Engagement**

OTR hosts webinars and other trade engagement events to provide updates on CBP programs and policies directly impacting the small business community. The office also occasionally works directly with the Office of the National Ombudsman (ONO) to facilitate outreach to the small business community.

OTR works with CBP component offices to facilitate international outreach and engagement with the international business community.



# **Maintaining Trade Relations**

U.S. Customs and Border Protection

Trade Symposiums emerged from the Customs and Modernization Act of 1993 and the agency's resulting obligation to provide the trade community greater information regarding their rights and responsibilities under customs regulations and laws.

Trade Roundtables are held within various CBP Field Offices to provide local industry representatives an opportunity to engage with CBP Executives regarding trade challenges or opportunities that impact the local trade community.

Trade Days provide key trade stakeholders an opportunity for an open dialogue with the Commissioner, Deputy Commissioner and key CBP Executives to hear updates on CBP priorities and discuss d trade related concerns.

# **Trade Messaging**

Speaking Engagements: OTR's staff makes itself available as a resource to the small business community. We are happy to coordinate with a speaker or show up ourselves to deliver trade messaging. We are committed to enhancing CBP's collaboration with its trade community partners.

Webinar Program: OTR established a webinar program to support CBP's bi-directional education with the trade community. Webinars are recorded and posted to the CBP.gov website for additional viewing and education beyond the live webinar.
